RESOLUTION OF THE SWAIN COUNTY BOARD OF COMMISSIONERS TO RESCIND SWAIN COUNTY’S REVALUATION SCHEDULE FROM JANUARY 01, 2009, TO JANUARY 01, 2013 AND TO IMPLEMENT SUBSEQUENT REAPPRAISALS EVERY EIGHT YEARS THEREAFTER

WHEREAS; Swain County completed and implemented its most recent octennial reappraisal of real property on January 01, 2005, utilizing Wampler & Eanes reappraisal firm: and

WHEREAS, Swain County advanced the reappraisal process by resolution, as required by G.S. 105-286(a)(2) on August 9, 2005,

WHEREAS, House Bill 1530 of the General Assembly of North Carolina session 2009 (G.S. 105-286 (d)) has given authority to counties in North Carolina to rescind the advancement of the reappraisal process back to the original octennial plan reappraisal as set forth in G.S. 105-286 (a)

NOW, THEREFORE BE IT RESOLVED by the Swain County Board of Commissioners of Swain County (“Board”) that the resolution entitled, “RESOLUTION OF THE SWAIN COUNTY BOARD OF COMMISSIONERS TO ADVANCE SWAIN COUNTY’S REVALUATION SCHEDULE FROM JANUARY 1, 2009, TO JANUARY 1, 2013 AND TO IMPLEMENT SUBSEQUENT REAPPRAISALS EVERY EIGHT YEARS THEREAFTER”, adopted August 9, 2005, be rescinded and that Swain County’s next reappraisal will be January 1, 2013 and will be conducted every eight years thereafter as set fourth in G.S. 105-286 (a)(1)

BE IT FUTHER RESOLVED that a copy of this resolution be forwarded promptly by the Clerk to the Board to the Department of Revenue as required by G.S. 105-286 (d)(1).
