GS 163-33(8) Swain County Board of Elections gives Notice of the General Election on November 6th, 2012. Polls will be open from 6:30a.m. until 7:30 p.m. at the following locations: BC #1 Chamber of Commerce, 210 Main St. Bryson City, BC #2 Swain County Administration Building , 101 Mitchell St. Bryson City. Alarka #3 3601 Alarka Rd. Bryson City, Almond #4 60 Almond School Rd Bryson City, and Whittier –Cherokee 135 Whittier Depot St. Whittier.

Absentee voting by mail begins September 7th, 2012. This is open to all Swain County Voters. Request for absentee ballots must be made in writing and postmarked by 5:00 pm in the Swain County Board of Elections mailing address at PO Box 133, Bryson City, NC 28713 and the Swain County Board of Elections office by November 5th, 2012 by 5.00 pm. One-Stop Voting begins October 18<sup>th</sup> , 2012 from to 8:00am until 5:00pm Monday through Friday and on November 3<sup>rd</sup> from 9:00 am until 1:00 pm at the Board of Elections office located at 1422 Hwy 19 S. Bryson City, NC 28713. There will also be one-stop voting available at the Ginger Lynn Welch Center located at 37 Cherokee Boys Club Loop Cherokee, NC 28719. Hours will be beginning October 18<sup>th</sup>, 2012 from 12:00 pm until 7:00 pm Monday through Friday and on Saturday November 3<sup>rd</sup>, 2012 from 9:00 am until 1:00 pm.

One-Stop voting sites will **ONLY** be open the one Saturday November 3<sup>rd</sup>, 2012 for voting.
